- (1) A plan must be submitted and signed by the City Engineer Medford Engineering Department located in City Hall Room 300. This plan should consist of a detail of the Assessors Map where the project will take place. A line must be drawn on all sides 100-feet from the project parcel boundary.
- (2) Once the City Engineer signs the Assessors Map Plan, the Applicant will bring this form, filled out and the City Engineers signed Assessors Map Plan, to the Assessors Office located at City Hall Room 105.
- (3) The abutter certification process takes on average about two weeks, therefore Applicants must plan accordingly.
